Regulation

1) How to apply for a badge and fill out the form

If you wish to purchase a season ticket, fill out the request form, which can be requested at one of Busitalia Veneto S.p.A. ticket offices. The application must be completed in full and accompanied by a recent photo. A self-certification concerning your employment relationship or student status at the educational establishment specified is sufficient. For minors, the self-certification must be signed by the person with parental responsibility. For shift workers, an employer's statement is required. Customers benefiting from bus fare reductions (pursuant to Regional Law 19/96) are required to submit a copy of the Regional Badge issued by the province, along with their photo. Inter-city season ticket fares will be calculated taking into account the fare for the bus service requested. If the bus service requested is available on several lines, the season ticket fare will be based on the bus service with the greatest number of connections. Please note that, for inter-city lines, when boarding at a stop not included in the season ticket fare, the fare of the previous stop shall apply, and when heading to a stop not included in the season ticket fare, the fare of the area shall apply.

2) Provisional badge

Hand in the badge request to an authorised ticket office. If the office is equipped to do so, it will immediately issue the final badge, otherwise it will issue a provisional badge authorised for the purchase of the season ticket. You are required to check that all data provided on the provisional badge is accurate and report any corrections to the ticket office operator. Upon collection of the provisional badge, you are required to pay for it in accordance with the current fare.

3) Final badge

Based on the data provided in the request, Busitalia Veneto S.p.A. issues the final badge and delivers it to the ticket office. You must go to the ticket office where you handed in the request to collect the final badge, within the deadline notified by the ticket office. If you do not have a provisional badge yet, you must purchase the season tickets from the same ticket office that issued the provisional badge. The final Busitalia Veneto S.p.A. badge is valid 3 years from the request date. Upon its expiry, you must submit a new request in the same manner. A valid ID is required every time a season ticket is purchased. No season tickets with a period of validity ending after the badge expiry may be issued. The badge is strictly personal and non-transferable to third parties.

4) Changing the badge data

The final badge's main purpose is the purchase of monthly tickets. Should you have other requirements (e.g., purchase of a weekly or annual ticket, alternating the purchase of a weekly ticket with that of a monthly ticket or vice versa, or purchasing an integrated inter-city + urban monthly ticket for the Padua area), please inform the ticket office operator in advance about the change in the type of season ticket and, consequently, of the fare applied. These operations are free of charge and the badge remains valid. In the event of a change of category or a change of residence (outside the municipalities agreed upon in the season ticket), you need to request a new badge to the ticket office, at the current cost.

5) Duplicate badge

In the event of theft, loss, breakage or deterioration, you may request a duplicate badge, at the current cost.

6) Refunds

You are not entitled to claim a total or partial refund for any unused periods concerning badges or tickets, except in special cases objectively justified, and only concerning annual tickets, subject to the Company's discretionary assessment.

7) Obligation to show the season ticket/badge

When boarding a bus, you are required to show your season ticket to the driver. The season ticket must also be exhibited to the company inspection staff and to public-sector security personnel, along with your badge.

8) Penalties

If you do not have the season ticket with you, even with a valid badge, you must purchase a regular one-way ticket. If you fail to do so, you will be subject to the administrative penalties provided for by the applicable Regional Law.
